FOREWORD

The European Association for Banking History e.V., founded on 29th November 1990, spans two domains — that of banks on the one hand, and scholarship on the other. The main objective of the Association is to initiate a dialogue between these two quite separate realms. It therefore aims to stimulate and foster historical awareness and the maintenance of archives in banks, and, at the same time, to promote research into banking history. The dual nature of the EABH is also reflected in the composition of its Academic Advisory Council, whose members include both heads of bank archives and professors of history. This composition guarantees differing approaches to the same issues, and thus the generation of different ideas, influences and stimuli.

In the interest of obtaining a wide spectrum of ideas, the European Association seeks to co-operate with academic institutions with similar objectives, such as the Swiss Association for Banking History, Berne, the Institute for Bankhistorical Research, Frankfurt, the Business Archives Council, London, and the International Council on Archives, Paris. The widest possible scope and impact are attained by including also the banks' press and marketing departments in this work.

In keeping with its twofold orientation, the European Association for Banking History organizes each year an »Academic Colloquium« on a specific aspect of European banking history, and a »Colloquium on Bank Archives«. In the banking field as elsewhere, archives have been and will remain the basis for any historical research. However, alongside their commitment to academic research, bank archives have to fulfil numerous other responsibilities within their banks. They have to act as »Historical Information Centres«, that is, as service departments to the management, to other departments, to branches and the public.

In order to meet the various demands placed upon them, the archives must have at their disposal a maximum of knowledge and organization; yet they generally possess no more than a few members of staff. For this reason it is essential that they be enabled to maintain a maximum of historical data with a minimum of effort. Modern technology and methods of organization can play a key role here. The dialogue between heads of bank archives across the European frontiers may open up new horizons, facilitating common
